Guide to the City Commission Proceedings

The Oral Communication portion of the agenda is for members of the public to present items which are not listed on the agenda, but are under the subject matter jurisdiction of the Commission. Although no action may be taken, the Commission and staff will follow up, at an appropriate time, on those items needing response. Each speaker is limited to (3) three minutes. Time may be surrendered by deferring (1) one minute to another speaker, not to exceed a total of (8) eight minutes. The speaker wishing to defer time must be present when the item is heard. In order to be recognized and present an item, each speaker must complete and submit to the Recording Secretary a Request to Speak form prior to the beginning of the item being announced by the Chair (forms are available at the entrance to the meeting room). Speakers are taken in the order slips are submitted.

Items in Consent Calendar Section A have already been considered by the Commission at a previous meeting where the public was invited to comment, after which a decision was made. These items are not subject to public discussion at this meeting because the vote taken at the previous meeting was final. Resolutions concerning decisions made at previous meetings are for the purpose of memorializing the decision to assure the accuracy of the findings, the prior vote, and any conditions imposed.

Items in Consent Calendar Section B have not been discussed previously by the Commission. If discussion is desired, an item may be removed from the Consent Calendar for individual consideration. Commissioners may indicate a negative or abstaining vote on any individual item by so declaring prior to the vote on the motion to adopt the entire Consent Calendar. Items excluded from the Consent Calendar will be taken up by the Commission following the action on the Consent Calendar. The Commission first will take up the items for which public speaker requests have been submitted. Public speakers shall follow the rules as set forth under Oral Communication.

Old Business items have appeared on previous agendas but have either been continued or tabled to this meeting with no final action having been taken. Public comment shall follow the rules as set forth under Oral Communication.

Items in New Business are items which are appearing for the first time for formal action. Public comment shall follow the rules as set forth under Oral Communication.

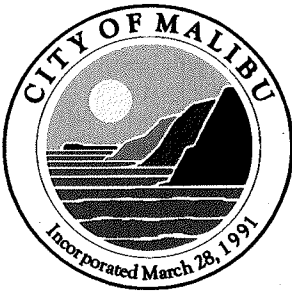

Commissioner Andrew Springer offered to burn the films on to a DVD through his existing subscription to Dropbox and indicated interest in volunteering as the event photographer.

Commissioner DeAngelis stated that she and Commissioner Perlmutter screened eligible films earlier in the evening and expressed interest in serving as an event emcee.

Commissioners Jennifer Orian and Sorin Moore volunteered to sell tickets the day of the event.

Commissioner William Kish volunteered as an usher.

Commissioner Russell Kish volunteered to assist with event set-up and clean-up.

A. Malibu Teen Music and Art Festival

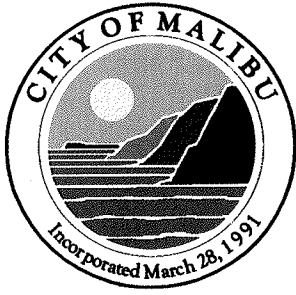

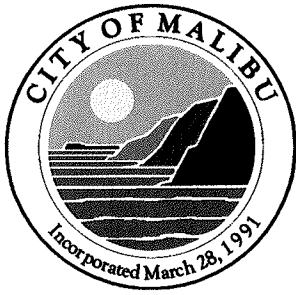
DISCUSSION: Since 2015, the Youth Commission has hosted the Malibu Teen Film Festival. This year's event fulfilled the City Council's assignment to engage teens in a multimedia program through a Youth Commission-sponsored event.

At the September 19, 2016 Youth Commission meeting, the Film Festival Subcommittee was established to include Commissioners Zita Surprenant, William Kish, Russell Kish, Miela Efrain, Rachel DeAngelis and Morgan Perlmutter.

The Teen Film Festival was held on Friday, January 13, 2017 at the Malibu Civic Theater and had approximately 85 guests in attendance. Event elements included a red carpet, step and repeat, complimentary popcorn, a screening of the top twenty-one films, awards for the top four films and a dessert reception. Filmmakers received two complimentary tickets and additional admission tickets were sold at the door for \$5 per person.

Eleven Commissioners volunteered the day of the event from 5:00 p.m. to 10:00 p.m. Commissioners assisted with ushering, ticket sales, event photography, emceeing, reception set-up and event clean-up.

Subject: Malibu Teen Music and Art Festival

RECOMMENDED ACTION: Discuss event elements and Commissioner assignments for the Malibu Teen Music and Art Festival scheduled on March 24, 2017.

DISCUSSION: The Youth Commission has been given assignments by the City Council to 1) Coordinate and conduct a talent or music event, including an opportunity for the winners to perform at a City special event and 2) Create an ad hoc committee that will meet with members of the Cultural Arts Commission with the intent to organize educational art opportunities or an event that showcased middle school and high school students' artwork.

Since 2006, the Youth Commission has hosted the annual Battle of the Bands event. At the September 19, 2016 meeting, the Youth Commission discussed revising Battle of the Bands by adding an art element to complete both assignments. The Commission supported changing the name of the event to the Malibu Teen Music and Art Festival.

Commissioners Collette Aldrich, Abby Droeger, Quinn Graham, Katherine Hall, Grace Kinyon, Luca Moore, Jennifer Orian, Tripp Principe, Maximilan Roth and Lola Stanley will be working together to complete the assignment.

The Art Festival Event Subcommittee created an ad hoc committee that will make a presentation at the Cultural Arts Commission meeting on February 28, 2017.

The Malibu Teen Music and Art Festival is scheduled to take place at 6:00 p.m. on Friday, March 24, 2017 at the Malibu Civic Theater. Event elements will include an

art exhibit on the lower level of Malibu City Hall, musical performances in the Malibu Civic Theater and a reception.

Commissioners may discuss assignments such as: recruitment of judges, awards, sponsors, ushers, ticket sales, photographer, emcee, event set-up and clean-up.
