NOTICE OF CONTINUANCE

All items scheduled for the hearing have been continued to the April 16, 2018 Regular Planning Commission meeting, including:

Coastal Development Permit No. 14-073, Variance Nos. 18-002, 18-003, 18-004, 18-008, 18-009, and 18-010, and Minor Modification No. 18-001 – An application for a new single-family residence and associated development located in the Rural Residential-Two Acre zoning district at 33386 Pacific Coast Highway.

Coastal Development Permit No. 14-072, Lot Merger No. 17-007, Lot Line Adjustment No. 14-004, Variance Nos. 17-050, 17-051, 18-001, 18-005, 18-006, and 18-007, and Minor Modification No. 17-022 – An application for a new single-family residence and associated development, lot merger, and lot line adjustment located in the Rural Residential-Two Acre zoning district at 33398 and 33390 Pacific Coast Highway.

Extension of Coastal Development Permit No. 05-045 and Tentative Parcel Map No. 10-001 – A fourth request to extend the Planning Commission's approval for the subdivision of one 5.93 acre legal lot into three lots with no new development proposed at this time, with the exception of water system and street improvements required prior to final recordation of the parcel map located at 28811 Pacific Coast Highway.

Extension of Coastal Development Permit No. 07-142, Variance Nos. 07-063, 08-059, and 08-060, and Site Plan Review Nos. 07-138 and 11-027 – a fourth request to extend the Planning Commission’s approval of an application for the construction of a new, single-family residence and associated development located at 31345 Pacific Coast Highway.

Extension of Coastal Development Permit No. 05-143, Variance Nos. 06-030 and 08-031, Site Plan Review No. 06-090, Offer-to-Dedicate No. 09-002, Coastal Development Permit Amendment No. 14-004, and Variance No. 14-007 – A seventh request to extend the Planning Commission’s approval of an application for the construction of a new two-story single-family residence and associated development located at 34305 Pacific Coast Highway.

Extension of Coastal Development Permit No. 10-015, Variance No. 14-032, and Demolition Permit No. 10-016 – A request to extend the City Council’s approval for new construction of a single-family residence and associated development located at 24948 Malibu Road.
