Guide to the City Commission Proceedings

As a result of the Coronavirus (COVID-19) pandemic, the City is under a state of local emergency, as well as states of emergency that have been declared in the County of Los Angeles, state of California, and a federal emergency declared by the President of the United States. In order to reduce the risk of spreading COVID-19, the City Council meeting will be open and public but conducted virtually because meeting in person would present imminent risks to the health or safety of attendees. This way the public, the staff, and the Council will not be physically in the same place.

The Oral Communication portion of the agenda is for members of the public to present items, which are not listed on the agenda but are under the subject matter jurisdiction of the Commission. Although no action may be taken, the Commission and staff will follow up, at an appropriate time, on those items needing response. Each speaker is limited to (3) three minutes. Members of the public wishing to speak during the meeting must participate through the Zoom application. You must first sign up to speak before the item you would like to speak on has been called by the Chair and then you must be present in the Zoom conference to be recognized. RECOMMENDED ACTION: Discuss ideas for the 2023 Environmental Sustainability Program.

DISCUSSION: At the June 13, 2022 Regular meeting, the Council approved an assignment for the Youth Commission to create a program to promote environmental sustainability.

The City prides itself in being a leader in environmental stewardship and strives to educate and create programs to reduce environmental impacts. The City's primary objectives regarding sustainability include energy, water conservation, pollution prevention, waste reduction, coastal vulnerability, and outreach/events.

To meet the objectives, the City has coordinated various environmental programs such as beach clean-up days, clean water initiatives, firescaping workshops, rain barrel distribution, solid and organic waste recycling, shoreline restoration, and turf replacement incentives. City Council has also passed ordinances regarding plastic bag bans, the elimination of single-use cutlery, and the dark sky ordinance.

The Commission is asked to focus on one or more of the City's environmental objectives to determine a sustainability program for spring 2023.

Subject: Cultural Program

RECOMMENDED ACTION: Discuss ideas for the 2023 Chumash Native American Cultural Program.

DISCUSSION: At the June 13, 2022 Regular meeting, the Council approved an assignment for the Youth Commission to develop a cultural program to celebrate or bring awareness to the Chumash Native American Tribe.

Chumash Native Americans were Malibu's original settlers and inhabited various California regions, from Malibu to San Luis Obispo. "Humaliwo," the inspiration for the name Malibu, translates to "the surf sounds loudly."

The City honors the Chumash Native American Tribe annually during the Chumash Day Powow and Intertribal Gathering. This year the event will take place on Saturday, April 1, 2023, and Sunday, April 2, 2023, from 10:00 AM to 6:00 PM at Malibu Bluffs Park. The event includes ceremonial dances, songs, Chumash educational booths, and Native American art.

Historically, the Commission has volunteered at Chumash Day but has not coordinated a cultural event regarding the Chumash Native American Tribe. The Commission may host an art event, outreach booth, poetry program, or Native American speaking engagement.
