Guide to the City Commission Proceedings

As a result of the Coronavirus (COVID-19) pandemic, the City is under a state of local emergency. In order to reduce the risk of spreading COVID-19, the Commission meeting will be open and public but conducted virtually because meeting in person would present imminent risks to the health or safety of attendees. This way, the public, the staff, and the Commission will not be physically in the same place.

The Oral Communication portion of the agenda is for members of the public to present items which are not listed on the agenda, but are under the subject matter jurisdiction of the Commission. Although no action may be taken, the Commission and staff will follow up, at an appropriate time, on those items needing response. Each speaker is limited to three (3) minutes. Members of the public wishing to speak during the meeting must participate through the Zoom application. The City requests that you sign up to speak before the item you would like to speak on has been called by the Chair and then you must be present in the Zoom conference to be recognized. Items in Consent Calendar Section A have already been considered by the Commission at a previous meeting where the public was invited to comment, after which a decision was made. RECOMMENDED ACTION: Review and approve a recommendation by the Malibu Public Art Exhibitions Ad Hoc Committee to change the September 2023 Malibu City Gallery featured artist to Wes Van Dyke.

DISCUSSION: The Malibu Public Art Exhibitions Ad Hoc Committee (Ad Hoc Committee), consisting of Vice Chair Lawrence and Commissioner Holland, prepared a list of six art exhibitions for the 2023-2024 Malibu City Gallery Exhibition Schedule. On June 27, 2023, the Commission reviewed and approved four art exhibitions for Fiscal Year 2023-2024, including, a Dick Van Dyke Tribute Exhibition, Student Art Exhibition, Leigh McClosky Exhibition, and a Surf Culture Exhibition.

At the July 25, 2023 Regular meeting, the Commission unanimously approved a multi-artist photography exhibition for the September 2023 show and asked to additional time to review artists for the March 2024 (spring) exhibition.

Following the July 25, 2023 Regular meeting, the Ad Hoc Committee contacted several photographers for the upcoming show, and many were unavailable. In an effort to confirm an artist before the City's marketing deadline, the Ad Hoc Committee contacted artist Wes Van Dyke who agreed to show his work for a single-artist exhibition.

Wes Van Dyke works primarily in the oil painting medium, but enjoys trying other art styles and mediums. His work reflects realistic landscapes and seascapes, that are painted with an almost photo realistic affect. Mr. Van Dyke has shown his work in several exhibintions in the region and has been commissioned for work in the United States, Austrialia, and England.
