

Outreach Coordinator Weekly Update

October 20-24

Agoura Hills:

OC canvassed Agoura Meadows and Twin Oaks shopping centers several times this week.

OC canvassed I-Hop shopping center several times this week.

OC canvassed Agoura Rd, T.O. Blvd, Kanan Rd, Reyes Adobe Re and Canwood St. several times this week.

OC and JT Manwell, Public Safety Liaison engaged PEH panhandling at 101 fwy. exit near Kanan and Roadside. PEH is service resistant and did not accept a list of service providers. PEH stated that he is passing through the area and has been seen in T.O. previously.

OC was informed that a PEH is camping at the Tavern Tomoko, and it appears to be A65.

OC, JT Manwell and LAFH Outreach engaged A65 at Tavern Tomoko to let her know that construction is soon to begin on the building. LAFH Outreach to submit a referral to DMH for services. OC to follow up.

A small encampment was located at Canwood St. and Robles Ln. Signage for removal was posted on Thursday, October 23. New contact: Female, 50s. PEH did not engage and walked away.

OC was informed that DMH may try to connect with A65 on Friday. If they cannot make it they will come out next Wednesday. OC updated JT Manwell.

Calabasas:

OC canvassed The Commons/Courtyard several times this week. No new contacts.

OC canvassed Old Town several times this week. No new contacts.

OC canvassed Calabasas Rd, Parkway Calabasas, and Park Granada several times this week.

OC canvassed Creekside Village several times this week and checked under the Agoura St. Bridge.

OC engaged C71 while sleeping in the parking lot of a local business. PEH declined interim housing last Friday. PEH stated that she contacted family but does not have a plan.

OC responded to a city request through the city's website outreach portal. Requester is a resident of the area and has seen a PEH panhandling near the 101 fwy exit at Valley Circle. OC will attempt to locate PEH on Thursday morning.

Hidden Hills:

OC canvassed Mureau Rd. several times this week. No new contacts.

OC checked in with security at Long Valley Gate. Nothing new to report.

Malibu:

OC participated in the internal homeless count on Monday morning.

OC engaged M10 at Legacy Park. PEH stated that he wants to give it another try at Turning Point or another facility in the Santa Monica/W. LA area. TPC Outreach is aware of the situation and is waiting for a bed to become available.

OC canvassed Central Malibu and engaged new contact: Male, 30s. PEH stated that he has been in the area for several weeks and is already working with TPC. PEH does not want to stay on the street for a prolonged period.

OC canvassed Trancas Country Market. No new contacts.

OC canvassed Zuma Beach board walk. No encampments or PEH were located on the beach.

OC canvassed Heathercliff. No new contacts.

OC engaged M10 at the Library to inform that he has been approved for a bed at Turning Point. TPC to pick up PEH on Thursday to transport to the facility.

OC attended lunch on Friday. Approximately 30 PEH participated.

Westlake Village:

OC canvassed Agoura Rd, T.O. Blvd, Lindero Cyn. Rd, and Russel Ranch Rd. several times this week.

OC canvassed Shoppes at Westlake Village several times this week.

OC canvassed the Marketplace shopping center several times this week.

OC engaged new contact: Male, 60s at the bus stop on Lindero Cyn. and T.O. Blvd. PEH stated that he was waiting for the bus. PEH stated that is does not qualify for housing in Ventura. OC
