

Outreach Coordinator Weekly Update

May 3 - 7

Agoura Hills:

OC connected with JT Manwell, Public Safety Liaison, for daily update. No new contacts this week.

Contacted JT Manwell who stated that A24 was at Ladyface Laundry. IND has not received his permanent License Plates in the mail. IND is currently working as a Door Dash Driver.

OC canvassed Agoura Meadows and Twin Oaks 4 days this week. OC canvassed Agoura Rd and Lindero Cyn Rd.

OC submitted an LA HOP for A27 who has been residing in Calabasas. OC did not receive a verification of contact email this week. OC coordinated with the MET Team to locate IND but was unable to engage this week. OC to meet with MET next Tuesday and make a second attempt to engage IND. OC to continue to submit updates regarding IND.

Calabasas:

OC received a request from Secure All Security regarding A27 who travels on foot between Westlake Village, Agoura Hills and Calabasas. OC located IND at the Courtyard Shopping Center on Calabasas Rd. OC continues to offer IND services. IND is service resistant. OC submitted an LAHOP #30477, however, IND moves around frequently and may be difficult to locate. OC to follow up.

OC and Deputy Mateo engaged Female, 30s next to the Westbound 101 on ramp. IND stated that she has a Dr. Appointment on Friday in Van Nuys. OC suggested Hope of the Valley as a service provider as they have a facility in that area. IND became aggravated at the suggestion of services. IND followed SD and OC to the cruiser and attempted to prevent SD from driving away. SD to inform Highway Patrol regarding the situation as IND is camped in their jurisdiction.



OC spotted C01 sleeping in the Gazebo on Calabasas Rd. OC did not wake IND. A27 was seen sleeping on a bench in the Courtyard Shopping Center. OC submitted an LA HOP but have not received verification of contact. OC to follow up.


OC was contacted by Deputy Mateo who stated that C01 was causing a disturbance at the Gazebo on Calabasas Rd. Deputies responded and IND was taken for Mental Health Observation.

OC engaged A27 at The Commons. IND refused services. IND has been sleeping in Calabasas. IND travels between Westlake Village, Agoura Hills and Calabasas. OC has not received a response from LA HOP. OC contacted the MET Team and will attempt to locate IND tomorrow. IND may be Gravely Disabled and a Public Health Hazard, to be determined by Mental Health Professional. OC updated Michael McConville, Management Analyst. OC to follow up.

MET located A27 sleeping in the grass on the corner of Parkway Calabasas and Park Granada. MET was unable to engage IND because there was no call # for deputy response. OC to meet with MET next Tuesday and engage IND. OC will offer IND services while the MET Team observes.

Malibu:

OC responded to a request from the city regarding an encampment in Bluffs Park. The encampment is on the hillside below the Baseball Field. OC and Deputy Espinoza attempted to speak to the individual who was at the encampment but would not respond to SD or OC. Female, 40s, has been seen at the lunch program. Name unknown and will be referred to as M15. OC will attempt to engage IND tomorrow at lunch. The encampment was clean and there was no sign of fire.



OC engaged M15 at lunch on Friday. IND was not interested in services and did not want to speak to OC.

OC and Deputy Espinoza canvassed Legacy Park. No encampments have been established at this time.

OC checked in with the Library as they have been open for 2 weeks. No issues regarding individuals experiencing homelessness.

OC checked in with Deputy Espinoza who has several pair of shoes for donation. OC to meet SD tomorrow.

OC canvassed Central Malibu and Zuma Beach Boardwalk daily this week.

OC received a shoe donation from Deputy Espinoza to distribute to individuals experiencing homelessness. SD informed OC regarding male, 30s who asked SD for help. OC connected IND to TPC and Dr. Ryan, Mental Health, who outreach every Thursday. IND to be referred to as M16.

25 - 30 individuals participated at each of the 3 lunches this week.
