

Outreach Coordinator Weekly Update

July 6 - 9

Agoura Hills:

OC engaged A13 at Duncan Donuts on T.O. Blvd and Lindero Canyon Blvd. IND stated that his father is to pick him up this afternoon for an appointment in Thousand Oaks. IND will be signing up for services at Lutheran Social Services. OC to follow up with IND.

OC contacted JT Manwell, Public Safety Liaison, daily for updates.

OC canvassed Twin Oaks and Agoura Meadows shopping centers daily. No new contacts.

OC checked the Kanan Park and Ride where a truck trailer appeared to have been parked over night. There was no activity at the time. OC returned in the afternoon and the vehicle had left the area. OC to follow up tomorrow AM.



OC checked in with JT Manwell and notified him of the truck trailer that was parked at the Park and Ride. Nothing else to report.

OC checked in at the Library. No issues to report.

OC checked the Park and Ride Friday morning. No overnight campers were spotted.

Calabasas:

OC received a notice that an IND was sleeping in front of the Library. Secure All was notified and the IND left the area. OC did not locate IND while canvassing the area.

OC canvassed The Commons, The Courtyard and Calabasas Rd. on several occasions. No contacts.

OC checked in with the manager of The Six Restaurant. No new issues to report.

OC was notified of an incident that took place on Agoura Rd. An individual experiencing homelessness had a gas can, poured the fuel on the road and lit it on fire. SD arrested IND for arson. IND stated that he was from Venice Beach. The MET Team was contacted and may be transporting IND to Olive View Hospital for observation.

OC met with security at The Promenade who informed OC that an individual experiencing homelessness has been frequenting the mall and harassing patrons. IND was currently loitering

in the parking lot. OC and security attempted to engage male, late 20s. IND did not engage and walked away.

OC canvassed Civic Center. No contacts.

OC received a report about a small abandoned encampment on Parkway Calabasas and Park Granada. The items are to be removed and disposed of. OC to recheck the location next week to see if IND has returned.



Hidden Hills:

OC checked in at Round Meadow Security Gate. No recent issues at the Gazebo on Mureau Rd.

Malibu:

OC checked in with Deputy Espinoza. SD walked Tuna Canyon on Monday and several INDs were contacted.

OC engaged M12 at Malibu Creek. IND was forced to move out of Legacy Park due to the recent fire. IND is receiving services from TPC.

OC assisted at lunch on Tue, Thur, and Fri. Approximately 20 - 25 IND participated each day.

OC checked in with security at Ralphs shopping center daily.

OC, Deputy Espinoza and Scott E. from TPC canvassed the large vacant lot across from Bluffs Park. The area has been recently cleared of most vegetation for fire safety. M18, male, 30s recently moved back to the area. IND has resided in Malibu for many years and is working with TPC and continues to wait for a housing match.

New IND, Male, 40s who recently moved into the area. IND asked about the possibility of going into a treatment program. TPC to meet with IND tomorrow to discuss further. IND stated that he is from Colorado.

IND stated above did not show up to meet with TPC. OC to follow up with IND if located.

Female, 50s who has resided many years in Malibu and has been service resistant up to this point decided to set an appointment for next week to begin working on her housing. IND has family in the area and has specific locations in mind. IND to be referred to as M17 here forward.
