

Outreach Coordinator Weekly Update

October 4 – 8

Agoura Hills:

OC made daily check in with JT Manwell, Public Safety Liaison.

OC checked in with JT Manwell. A report came in of a possible individual experiencing homelessness sleeping on the grass at the Lake Lindero Golf Course. JT stated that the report may have been outdated.

OC canvassed Twin Oaks and Agoura Meadows. No contacts.

OC checked In with Danny at Lady Face Laundry. No issues to report.

OC canvassed Kanan Rd, T.O. Blvd and Agoura Rd. No contacts.

OC contacted JT Manwell for daily check in.

Calabasas:

OC canvassed De Anza Park and spoke to Phillippe, Grounds Keeper. The IND who was sighted in the park and believed to be experiencing homelessness has not been seen again. OC to continue check the area.

OC was notified by Michael McConville of an IND sleeping in his vehicle at 4235 Las Virgenes Rd. Allegedly, the vehicle has a broken wheel. OC to attempt to locate IND tomorrow morning. Secural has been notified but the guard has not received the information. OC to follow up.

OC responded to 4235 Las Virgenes Rd. where IND, male, 50s is parked with a vehicle that needs repairs. IND stated that the church is aware of his situation. IND stated that he has ordered a part and needs to pick it up. IND also stated that he knows someone who can install the part tomorrow, October 6th. OC drove to Sun Valley to pick up the part and was told by the salesperson that IND had called 20 minutes prior to cancel the order. OC to engage IND tomorrow. OC updated Michael McConville, Management Analyst.

OC stopped to follow up with IND who stated that a Sheriff Deputy stopped to check on him shortly after OC left. SD suggested IND cancel his auto part order as SD was not familiar with OC. OC was not aware of the cancellation and drove to Sun Valley for the part. IND stated that

someone he knows will pick up the part and install. OC stated that he would follow up with IND tomorrow.

OC was notified by the city that an encampment was being set up near Calabasas High School. OC verified IND as C02. OC arrived and spoke to AJ from Secural who was on location. IND was notified that he could not camp within 250 ft. of any school. OC also notified IND that an outreach team would be contacting him about his housing options. OC to follow up.



OC checked on IND whose vehicle was broken down at Church in the Canyon on Friday afternoon. Neither IND nor his vehicle was not at the location.

OC canvassed The Commons and Civic Center. No contacts.

OC canvassed Albertsons shopping center. No contacts.

Hidden Hills:

OC checked in at Long Valley Gate. No recent contacts.

OC checked in at the Burbank Security Gate. No issues to report.

Malibu:

New Contact: Male, 60s. IND has returned to Malibu after a long absence. IND stated that he lost his housing in Orange County. OC connected IND to Scott from TPC. IND to sign up for services and get on the housing list.

OC was contacted by Father Paul Elder, Episcopal Church, who informed OC of an IND, male, age unknown who is sleeping in the bushes at Heather Cliffe. A resident has complained that IND is sleeping under her window. OC to follow up.

OC canvassed Ralphs shopping center. OC was approached by female, 40s who asked for a cigarette. IND has frequented Malibu in the past and is a previous resident. IND suffers from substance abuse/mental health issues and has denied assistance in the past. IND has also been engaged in Agoura Hills. OC to follow up.

OC received a request from the city regarding an IND, male, age unknown who is experiencing homelessness in the Malibu area. IND has been trying to contact his mother without success. She contacted the city and forwarded photos of IND and would like to connect with her son. OC will look for IND and contact Susan Duenas, Public Safety Manager, if located.
