

## Outreach Coordinator Weekly Update

**October 25 – 29**

### **Agoura Hills:**

OC canvassed Twin Oaks and Agoura Meadows on 4 days this week.

OC contacted JT Manwell, Public Safety Liaison for daily update.

OC canvassed Old Agoura Park and Chumash Park. No contacts.

OC checked in with Danny at Lady Face Laundry. IND who may or may not be homeless is suspected of vandalizing the shop overnight.

New Contact: Male, 60s, sitting on a bench outside of Lady Face Laundry. IND stated that he is from Oxnard and is traveling on foot. IND has been experiencing homelessness for 7 years. IND is from Southern California. IND may or may not be a Veteran. IND spoke of fighting in Vietnam but denied veteran status. IND was given socks, poncho, and resource sheet. OC follow up.

### **Calabasas:**

OC met with Michael McConville and Deputy De Mateo to discuss process and procedures going forward with individuals experiencing homelessness.

OC engaged Female, late 40s, at the library. IND stated that she has been residing in the Thousand Oaks area. OC engaged IND in Agoura Hills several weeks ago. OC asked IND if she has tried to get housing with the organization Many Mansions in Thousand Oaks. IND stated that there is a 10 year wait list for housing. OC contacted Ann Sturman from Many Mansions who stated that the waiting list is closed due to the large number of individuals on the list. OC asked IND if she was familiar with Lutheran Family Services. IND stated she was familiar with the organization but does not utilize their services. OC contacted Daniel Moody, MET Team, and will come out to the area tomorrow. OC to follow up.

OC was contacted by Daniel Moody, SD MET Team, who stated that he was able to locate IND, female, 40s. IND was at The Commons. Daniel noticed that IND is having extreme difficulty with her feet but was not willing to have them looked at. Daniel decided that IND was gravely disabled and needs to go to the hospital. IND was not willing to go and became defiant. IND walked away and stated that she was going to get on the bus to Thousand Oaks. Daniel decided that there would be a physical altercation and IND was not willing to go voluntarily. IND stated that she is leaving the area. OC to follow up and notify Daniel Moody if IND returns to the area.

OC, Michael McConville, Management Analyst, Council Members Alicia Weintraub, Kindon Meik, and Peter Kruat toured the SFVCMHC Jorge Vega Center for Hope and a SRO Interim Housing Sites.

Council Member Peter Kruat rode with OC on a ride-along. There were new areas we canvassed that OC will add to weekly route. Gates Canyon Park on T.O. Blvd and Grape Arbor Park off Lost Hills Rd. OC will check these areas moving forward.

OC canvassed The Commons and Civic Center daily.

OC canvassed Mulholland Hwy near Calabasas High School.

OC canvassed Gelson's parking lot.

#### **Hidden Hills:**

OC checked the Gazebo on Mureau Rd and Round Meadow daily. No contacts.

#### **Malibu:**

OC partnered with Luis Flores, Public Safety Liaison, and outreached the Zuma Beach parking lot encampment. A clean up has been scheduled for November 9<sup>th</sup>. Signage was posted in the area on Monday. Several individuals remain in the area but are aware of the scheduled effort. We also met with Deputy Espinoza, HOST Team and The People Concern.

OC engaged Male, 40s. IND stated that he spoke to TPC once in the past and that they offered to find IND a shelter bed. IND stated that he was worried that they would place him on Skid Row. IND is not interested in going to a shelter but would like to discuss permanent housing options. IND needs to replace his documents but feels that he would have to travel to Texas and another state to acquire them. OC suggested that he speak to TPC Outreach as they may be able to assist. IND agreed. OC spoke to Scott regarding INDs concerns. OC to follow up.

OC canvassed Westlake Village Community Park and T.O. Blvd. No contacts.

OC canvassed Staples shopping Center and Duncan Donuts on T.O. Blvd. No contacts.
