### **November 1 – 5**

#### **Agoura Hills:**

OC received a request from the city regarding an individual that was reported as being in Sumac Park. IND was seen in the evening. OC spoke to JT Manwell, Public Safety Liaison, who stated that he was currently at the park and did not see anyone. OC to monitor the location.

OC spoke to Shane True, LAHSA, and Deputy Sheklo, HOST, about outreaching the area next Wednesday, November 10<sup>th</sup>. Shane forwarded his supervisors contact info and stated that it would be best if Luis Celaya, Deputy City Manager, submit a request. OC to follow up.

OC contacted JT Manwell, Public Safety Liaison, for daily updates.

OC canvassed Twin Oaks and Agoura Meadows. No contacts.

OC canvassed Kanan and T.O. Blvd. No contacts.

No individuals experiencing homelessness were sighted at Sumac Park this week.

#### **Calabasas:**

OC canvassed Albertsons, and The Commons several times this week. OC spoke to Allied Security who stated that he has not spoken to any INDs experiencing homelessness since early last week.

OC met Erin W. to pick up hygiene kits that her Girl Scout Troop assembled and donated. The girls are earning their "Considerate" and "Caring" Daisy Petal Patches. OC to distribute the items to individuals experiencing homelessness.

OC checked in with Michael McConville, Management Analyst.

#### **Hidden Hills:**

OC checked in at Burbank Gate. Nothing to report.

OC checked the Gazebo on Round Meadow and Mureau Rd. No contacts.

**Malibu:**

OC canvassed Central Malibu. No contacts.

OC checked in with Deputy Espinoza. Tomorrow, November 2<sup>nd</sup>, the SD HOST Team will be in the area. OC to meet with the team. OC to follow up.

OC, LAHSA Outreach, SD HOST Team, Chris and Gabe, Fire Safety Liaisons, and Deputy Espinoza outreached the Zuma Beach encampment. The cleanup is to take place next Tuesday, November 9<sup>th</sup>. There were 18 occupied encampments when the project began last June. There are now only 7 occupied camps. All the individuals that remain are aware of the cleanup. LAHSA is working to get one individual into a shelter. OC to follow up.

OC received a call from Brian, Head of Security at Pepperdine, regarding male, age unknown. M24 was contacted by campus security. IND has been attending online admittance courses via Zoom and wants to enroll at the college. IND showed up this morning to attend an in-person orientation that was not scheduled. Staff is concerned about IND. OC contacted IND and set up a meeting tomorrow morning. OC contacted TPC who will meet with him today. OC also contacted Kay Gabbard, CART, who is donating a sleeping bag. OC to follow up.

OC contacted M24 who stated that he is currently in LA. OC and IND were supposed to meet at Starbucks to discuss his options for services moving forward. OC asked IND to make contact if IND returns to the area.

OC engaged male, 40s. M25 stated that he is working with TPC and has been for a long time. IND stated that he has an apartment in LA but doesn't want to be there due to the unsanitary conditions at the building. IND has a housing voucher and is looking for another place.

OC checked in with Deputy Espinoza who contacted an individual at Zuma Beach who is interested in services. OC was not in the area at the time. SD to inform IND about TPC Outreach Team. OC to follow up on with IND on Monday.

**Westlake Village:**
