

Outreach Coordinator Weekly Update

November 22 - December 3, 2021

Agoura Hills:

OC and JT Manwell, Public Safety Liaison, met with LAHSA outreach and SD HOST team to outreach the area. The team engaged Male, 20s (A39) on Lewis Ave. IND is living in his van with his brother. They lost their apartment approximately 6 months ago. INDs stated that his brother has a construction job and was working at the time. IND stated that he works at a local gas station. Outreach spoke to IND about going to a Tiny Home site in the San Fernando Valley. IND seemed interested and is going to speak to his brother to see if he is interested. Shane, LAHSA Outreach, gathered INDs information and will follow up after the holiday weekend. OC to follow up.

LAHSA contacted IND, male, 60s (A40) who is living in his van. IND stated that he moves around and does not want services. IND is often parked near Starbucks on Kanan Rd.

OC and JT Manwell engaged A39 on Lewis Dr. IND has been living in his van with his brother who is a construction worker. IND stated that he spoke to his brother about moving into Tiny Homes in the valley. LAHSA Outreach will follow up with IND this week. OC donated a winter jacket and hygiene kits to IND. OC to follow up.

OC and JT Manwell met with HOST/LAHSA. We checked out an encampment off Agoura Rd. and Kanan. A29 has been camping on the Fire access Rd. There are signs of a campfire. See photos. IND was leaving the area as the team was arriving.



OC met with JT Manwell, Public Safety Liaison, Code Enforcement Officer, and Sheriff Deputies at the property on Agoura Rd. and Kanan Rd. The city acquired a Letter of Agency for said property. A29 has been staying in his vehicle at the location. Signs of fire were seen at the site. Also, several bunches of store-bought firewood were located on site. IND drove away after refusing to roll down his window to speak to deputies. Shift supervisor stated that he would not approve a revisit the site because there is not a barrier at the entrance to the area.

Calabasas:

OC contacted Deputy De Mateo regarding C02. SD stated that he would check the area where IND is known to stay to see if he is there. OC notified HOST and LAHSA that IND was not currently at his encampment.

OC met with Michael McConville, Management Analyst. OC updated Michael regarding last week's COG Homeless Working Group meeting. We also discussed the no camping ordinance.

OC canvassed The Commons and spoke to Juvie, Allied Security. Nothing to report.

Hidden Hills:

OC checked in at Long Valley gate. Nothing to report.

OC checked with the guards at Long Valley and Burbank gates. Nothing to report.

Malibu:

OC attempted to locate M07 for a follow up. Deputy Espinoza and OC were not able to locate IND on Westward Beach.

OC canvassed Central Malibu. New Contact, M28, Female, 30s was at Starbucks on Cross Creek. OC gave IND a winter jacket and hygiene kit. OC to follow up with IND if she is still in town moving forward.

New Contact: M30, female, 60s. IND was at Starbucks on Malibu Rd. OC gave IND a hygiene kit and attempted to engage. IND was speaking incoherently. OC to follow up.

OC engaged M29 who continues to work with TPC. IND left his apartment due to sanitary conditions. IND suffers from mental health issues. IND visited with Dr. King. IND is looking for another apartment. OC to follow up.

OC M08, who stated that he needed a break from his hotel and needed to speak to Dr. King from Venice Family Clinic. IND was able to connect with the Dr. and got a ride downtown from Tiffany, TPC. IND stated he is doing good and recently filled out his Section 8 paperwork. OC to continue to follow up with IND.

OC assisted with lunch today. Approximately 20 INDs participated. OC handed out hygiene kits.
