Agoura Hills:

OC checked in with JT Manwell, Public Safety Liaison daily.

OC met with JT Manwell and attempted to locate A06 who is camped next to the Green Belt. A letter of agency was obtained from the city. IND was not at the location. OC and JT checked Shell Station where IND can often be located without success.

OC and JT checked the Park and Ride on Canwood. No contacts.

OC and JT checked the bathrooms at Morrison Ranch Park. No contact.

Calabasas:

OC left a voice mail with Alessandra who contacted the city regarding an individual experiencing homelessness in Woodland Hills. OC attempted to gather more detailed information about IND and submit an LAHOP. OC to follow up.

OC did not receive a response from Alessandra this week.

OC left a voice mail with C15

OC canvassed The Commons several times this week. No new contacts.

OC checked in with SD Mateo.

OC canvassed the Civic Center and The Commons. OC spoke to Juvie, Allied Security who stated that a new individual experiencing homelessness has been seen in the area over the last week. OC to follow up.

OC connected with C15 by phone. IND stated that he has an appointment with Mental Health on Friday. IND continues to reply to OC's phone calls. IND's Aunt reached out to OC to gather information about the program. IND gave OC and Aunt permission to speak. Aunt is concerned about IND and is hopeful that IND stick with the program. OC contacted C15 by phone. IND continues to remove items from his encampment. OC reminded IND of his appointment at SFVCMHC today at 2:00 pm. OC to follow up next week.

OC updated Michael McConville, Management Analyst on progress made this week regarding C15.

Hidden Hills:

OC checked in at Long Valley Gate. No contacts with individuals experiencing homelessness.

Malibu:

OC attended the Tuesday lunch. Approximately 25 INDs participated. OC engaged M39 who is interested in outreach services and housing. IND stated that he is done living on the street. OC suggested that he meet TPC Outreach at the Malibu Library on Wednesday between 11:00 am and 1:00 pm. OC engaged IND in the past, but he left town. OC to follow up.

OC engaged M39 who stated that he met with TPC at the library on Wednesday and was given a referral for a shelter bed. IND to call to make an appointment. OC to follow up.

OC checked in with SD Espinoza.
