### **Agoura Hills:**

OC checked in with JT Manwell who located A06 and forwarded the contact info for a service provider in Ventura County.

OC received a request from the city regarding A06 who stated that he is working part time in Ventura. OC to forward a number for Harbor House, a service provider who may be able to assist IND in that area.

OC spoke to A06 about reaching out to the service provider in Ventura. IND stated that he has the number but hasn't called yet.

OC responded to a request from the city regarding a tent located at Medea Creek. OC and SDs visited the location. The site was vacant at the time. OC updated Louis Celaya, Deputy City Manager.



### **Calabasas:**

OC, SD Mateo, and Secure All accompanied city staff to Michael B's encampment for clean-up. IND was on site and corporative. IND reached out to his CM at The Center. IND to finish his assessment by phone.



OC checked in with Glenn from Allied Security at The Commons. No contacts today.

New contact: Male, 30s, C16. IND stated that he is living in his vehicle and was working in the area. IND not employed now. OC to follow up.

OC attempted to engage female, 30s at McDonalds. IND has been seen at Gates Park. SD's have been called out several times. IND will not engage SDs, Secure All, or OC.

OC reached out to C15. IND is frustrated and did not want to speak to OC. IND is supposed to receive a COVID test before returning to The Center.

OC canvassed The Commons and Civic Center. No contacts.

OC attended Coffee with Cops at Starbucks on Agoura Rd. OC spoke to several members of the community regarding Homeless Outreach.

### **Hidden Hills:**

Checked in at Long Valley Gate. No issues to report.

### **Malibu:**

OC received notice over the weekend that M11 has passed away at his camp.

OC checked in with SD Espinoza. We engaged M10 at Malibu Creek. IND has a large encampment that needs to be addressed. California State Parks is obtaining a trespass order.

OC was informed that M40, male, 50s, who has been house sitting in Malibu for many years is now officially experiencing homelessness. OC to follow up with IND to find out if he is interested in receiving services.

OC engaged M40 at Starbucks on Malibu Rd. IND has been house sitting and couch surfing in Malibu for many years. IND recently lost his current housing situation, and a local resident has reached out to the city. IND has several options in the works. IND is not willing to leave the Malibu area. OC to follow up.

OC engaged M03 at Malibu Rd. Starbucks. IND is working online and is waiting for his housing voucher to arrive.

OC reached out to Daniel Moody, MET, regarding M41. INDs mother was recently in town to visit. She has been attempting to convince IND to return home for many years. IND has been placed many times on a hold. Daniel Moody to reach out to mom by phone to discuss options moving forward.

OC attended Lunch. Approximately 20 INDs participated.
