### **Agoura Hills:**

OC submitted an LA HOP # 47255 for A35 at Twin Meadows.

### **Calabasas:**

SD De Mateo contacted OC to update on C02 who continues to camp across from Calabasas High School. IND was given a citation for camping in a high fire danger area. OC and HOST to visit the site tomorrow.

OC canvassed The Commons, Civic Center and The Courtyard. No contacts.

New Contact: Female, 40s. C22. was contacted by SD De Mateo. IND is from Newport Beach and plans on staying in the area. IND stated that she is not interested in services. OC to follow up. OC did not locate IND this week.

OC updated Michael McConville, Management Analyst.

OC, SD De Mateo and LAHSA Outreach attempted to locate C02 at his encampment next to Calabasas High School. IND was not at the location.

The outreach team engaged Female, 30s at The Commons. IND visited with LAHSA and was offered services. Daniel Moody, MET was notified due to concerns about INDs mental health. IND was detained on a 5150 hold.

OC checked in with SD Espinoza. Legacy Park underwent brush clearance.
