#### **Agoura Hills:**

OC canvassed Twin Oaks and Agoura Meadows four days this week. No contacts.

OC canvassed Old Agoura and Chumash Parks. No contacts.

OC responded to an email sent from the library manager who is filling in temporarily. M01 has been harassing visitors and staff. IND has been sleeping in front of the building for an extended period and the city is aware of the situation. OC to meet with library staff next week.

#### **Calabasas:**

OC canvassed The Commons. New Contact: Male, 50s. IND was looking for a US Bank. IND was missing a shoe. OC offered a hygiene kit and resource guide. OC to follow up.

OC engaged male, 40s at Civic Center. IND stated that he is working toward returning to family. IND was reluctant to share more information with OC. OC to follow up.

OC engaged M13 at Starbucks on Agoura Rd. IND was arrested in Malibu last Thursday. IND was released Friday morning and remains in the area. IND is service resistant but will engage with OC frequently.

OC engaged C07 in front of Albertsons. IND continues to state that he is leaving town. IND resides in his vehicle and recently shipped his household belongings out of the area. IND was utilizing a storage unit in the city. OC to follow up.

OC responded to a request from the city regarding an outreach request submitted by an individual experiencing homelessness. Male, 30s.(C27). IND is from Santa Barbara and has a section 8 voucher. IND has attempted to locate housing in Santa Barbara without success. IND is looking to port his voucher to LA County. OC referred IND to HOTV for housing navigation and case management services. OC also suggested a Safe Parking provider. OC gave IND a list of resources and will follow up with IND tomorrow. IND has a vehicle and is mobile.

OC met with C27 for update. IND stated that he signed up for services at HOTV. IND can utilize the showers and laundry facility at the Navigation Center. IND requires a follow up appointment at the Help Center in Van Nuys to receive housing navigation services and to discuss the voucher porting process. OC to follow up with IND.

Blvd. OC engaged IND who stated that she has called service providers in the San Fernando Valley to check on bed availability. OC suggested that she check availability daily.
