

## Outreach Coordinator Weekly Update

### **September 12 – 16**

#### **Agoura Hills:**

OC received a request regarding C23 who was engaged at Reyes Adobe Park. IND stated that she is currently working with Ventura County on acquiring a bus ticket to Pennsylvania. When OC asked for further details, IND became frustrated and walked away. OC to follow up.

OC canvassed Twin Oaks and Agoura Meadows on several occasions this week. No new contacts.

Daily check in with JT Manwell, Public Safety Liaison.

OC canvassed Whizins Mall with JT Manwell. No contacts.

OC received a notice from Victor A., LAFH Public Spaces Outreach, who is going to contact A01 this week.

OC verified that LAFH Public Spaces Outreach contacted A01 yesterday and will continue working with IND to attain permanent housing.

OC met with Louis C., Deputy City Manager for updates.

OC received a request regarding C22 who was seen at Morrison Park. IND continues to lock herself in the bathroom. JT confirmed that the IND was not at the location this morning. OC to follow up.

#### **Calabasas:**

OC checked in with Allied Security at The Commons. C29 continues to utilize Barns and Noble but was not in the area at the time.

OC canvassed The Commons and Civic Center several times this week. No new contacts.

OC canvassed Albertsons shopping center several times this week. OC engaged C17 to ask if IND is interested in attending Malibu Connect Day. IND stated that he has everything he needs and will not be attending the event. IND remains service resistant.

OC canvassed The Commons and checked in with Allied Security. No new contacts. OC engaged C29 at Starbucks and gave him a flyer for Malibu Connect Day. IND showed interest and plans on attending.

OC received a notice about a possible encampment in the creek bed north of the 101 freeway. OC and Michael McConville attempted to locate access to the area without success.

OC was notified that a possible encampment is set up on the hillside across from CHS. This may or may not be C15. OC to follow up with SD De Mateo on Monday.

### **Hidden Hills:**

OC checked in with Long Valley Gate. An IND experiencing homelessness continues to pan handle on the island in front of the gate. IND was gone by the time OC arrived.

OC canvassed Mureau Rd. and checked the gazebo on Round Meadow several times this week. No contacts.

### **Malibu:**

OC canvassed Central Malibu. No new contacts.

OC was contacted by Kay Gabbard, CART. M10 has been charged with a felony for a situation that took place over the weekend with another IND experiencing homelessness. M10 would like OC to advocate for him with his court case. OC to meet with IND next week to discuss.

Daily check in with SD Espinoza.

The 2022 homeless count reflects an extensive drop of individuals experiencing homelessness from 2020. The official number is eighty one.

### **Westlake Village:**

OC responded to a request that was submitted over the weekend regarding two females that have been sleeping in Russell Ranch Park. There is concern that one or both INDs may be using drugs. OC engaged C22 who was in the park when OC arrived. IND was previously engaged at Gates Canyon Park in Calabasas. IND is service resistant and continues to show hostility when approached. OC notified SD Knott who is aware of the situation. OC also updated Timothy I, Safety Inspector.

OC canvassed Westlake Village Community Park. No contacts.
