

Outreach Coordinator Weekly Update

September 26 - 30

Agoura Hills:

OC canvassed Twin Meadows several times this week.

Daily check in with JT Manwell, Public Safety Liaison.

OC canvassed Civic Center. No contacts.

OC checked in with JT Manwell who stated that an IND has been sleeping in his vehicle at the Park and Ride on Canwood St. OC engaged IND and forwarded a list of Safe Parking resources. OC to follow up.

OC canvassed Forrest Cove Park. No contacts.

Calabasas:

OC attempted to contact the manager of 7/11 on Las Virgenes without success. OC to follow up.

OC canvassed The Commons and Civic Center several times this week. No contacts.

OC checked in with Allied Security. No new issues to report.

OC and SD Mateo located the encampment on the hillside across from CHS. C15 reestablished his encampment after being banned from the area several months ago. IND decided he did not want to work with SFVCMHC interim housing program due to the policy requirements. IND stated that he continues to work with a CM from the organization. IND was given an additional 72 hrs. to vacate the location.



OC received a request from the city outreach portal. IND, female, age unknown is living in Las Vegas and is considering re-locating to LA where she is from. IND's mother resides in Pomona. IND has two small children and is expecting another this December. IND is not able to stay at her mom's but thought Calabasas is a nice area. OC explained that there is a lack of resources locally and that service providers in the greater LA area are overburdened at this time. OC

strongly discouraged uplifting IND's family if she is in a secure environment to move to LA. OC forwarded a list of resources.

OC responded to a request from the city. New contact: David, male, 20s. IND was pan handling in front of Wells Fargo on Calabasas Rd. IND stated that he usually resides in the San Fernando Valley. OC informed IND of the no camping ordinance in Calabasas. OC also directed IND to Hope of the Valley to utilize their services.

Hidden Hills:

OC checked in with security at Long Valley Gate. No new encounters.

OC canvassed Mureau Rd. several times this week. No issues to report.

Malibu:

OC checked in with SD Espinoza several times this week.

OC attempted to locate M10 at his encampment at Malibu Lagoon. IND went to court last Friday. IND was not at the location. IND did not participate in lunch today.

New Contact: Female, 30s. (M51). IND stated that she is from Brooklyn, NY and came to LA during COVID 19 lockdown. IND was staying with a friend until she had to vacate the location. IND stated that she lost her documentation when she was robbed. OC connected IND to TPC and will meet tomorrow at the library to complete her intake for services. OC to follow up.

OC verified that M51 met with CM for intake.

Approximately 30 INDs participated at lunch Tuesday and Thursday.

27 vendors, 25 volunteers and 64 confirmed participants attended last Thursdays Malibu Connect Day event.

SJC Outreach, SD Espinoza Luis F., Public Safety Liaison and OC hiked Tuna Canyon. We located two previously known active encampments. The team informed INDs of the current state of emergency for fire danger that went into effect this week. INDs have been informed that the area will be cleared out soon. Several vacant encampments remain in the area. Approximately 5 individuals continue to camp in the canyon. SD's and outreach are familiar with INDs.

OC engaged M10 who continues to make it to his court dates. INDs next appearance is Monday, October 3rd. OC to follow up.
