

Outreach Coordinator Weekly Update

October 17 – 21

Agoura Hills:

OC responded to a request from the city regarding female, 40s. A39 is loitering at Vons shopping center and has generated several calls to Lost Hills. Daniel Moody, MET was also notified and submitted an LAHOP # 53782. OC engaged IND who stated that she grew up in Agoura Hills and wants to rent an apartment locally. IND is waiting for her SS back pay. IND is not interested in receiving services. OC forwarded a list of providers anyway. OC located a profile in the HMIS system and has an extensive history of homelessness.

OC engaged A06 who was riding his bicycle through the parking lot at Vons. OC reminded IND that he may get arrested for trespassing. IND appears not to understand that he is banned from the entire property. IND asked for an ID voucher. OC will ask LAHSA outreach for a second ID voucher next time they visit the area.

OC updated Louis C., Deputy City Manager and JT Manwell, Public Safety Liaison.

A39 continues to loiter on the sidewalk in front of Latigo Kid Restaurant. OC notified JT Manwell. OC is unaware if IND was harassing drivers today. Daniel Moody, MET submitted an LAHOP yesterday.

OC canvassed Twin Oaks and Agoura Meadows several times this week.

OC met with JT Manwell and Daniel M, MET to discuss the situation with A39. IND is not currently a danger to herself or others however, IND is panhandling aggressively in the parking lot in front of Latigo Kid Restaurant. IND began generating calls to Lost Hills immediately upon arrival on 10/18/22. IND stated that she is waiting for her ID to arrive by mail at an old residence. IND is also waiting for SS back pay. OC asked if it was possible to return to her formal rental upon receiving funds. IND stated that she is not willing to return. IND has a history in the HMIS system. An LAHOP# 53782 was submitted by MET. OC will assist the responding outreach team to locate IND.

Calabasas:

OC canvassed The Commons and checked in with Allied Security several times this week. An individual experiencing homelessness was asked to leave the property due to his behavior. OC to follow up.

OC canvassed Albertsons center and engaged C07 who stated that he is still planning on moving to Nevada. IND is having car problems and vision problems and wants to work with his local physician. OC to follow up.

OC was informed that C30 reached out to the city a third time. OC contacted IND and made several additional suggestions regarding service providers that may be able to help. OC updated Michael McConville, Management Analyst.

OC received a request from Allied Security at The Commons regarding an IND who may be experiencing homelessness. OC responded but was unable to locate IND. OC to follow up. OC engaged M13 at the bus stop on Agoura Rd. and Las Virgenes. IND continues to be service resistant. IND may return to Malibu where he has been living for many years. IND usually frequents the city after being released from Lost Hills Sheriff Station.

OC canvassed Albertsons several times this week. No new contacts.

OC responded to a request from the city outreach web portal. IND did not answer two calls. OC forwarded a list of resources by email.

OC checked in with Long Valley Gate.

OC canvassed Mureau Rd. several times this week. No contacts.

Malibu:

OC checked in with SD Espinoza who stated that a female has been walking around with no clothing. IND is covering up with a blanket. IND will not engage SD or Outreach. OC to follow up with SD regarding IND and request the MET Team.

OC attended lunch. Approximately 30 INDs participated.

OC canvassed Ralphs Shopping Center. No new contacts.
