### **Agoura Hills:**

Daily check in with JT Manwell, Public Safety Liaison.

OC canvassed Twin Oaks and Agoura Meadows several times this week. No new contacts.

### **Calabasas:**

OC canvassed The Commons and spoke to Allied Security who stated that he asked C32 to leave the property for drinking in public. IND became agitated and began yelling. OC engaged male, 30s. M54 arrived approximately six weeks ago. IND has not connected with TPC. OC suggested IND complete intake even though he is not interested in housing at this time. OC to follow up.

OC was unable to locate M53 or her vehicle after initial contact on Monday.

OC canvassed Central Malibu, No new contacts.

OC attended lunch on Tuesday. Approximately 30 INDs participated.
