

Outreach Coordinator Weekly Update

Outreach Coordinator canvasses all five COG cities daily.
Below is a summary of coordinators activities.

Agoura Hills:

OC received a request from Public Safety regarding male, 40s. (A40) was pan handling in front of Rite Aid. IND stated that he arrived from Thousand Oaks. IND is traveling with his dog. IND stated that he has a difficult time staying in one place long enough to receive services. OC submitted LAHOP # 54833. OC to follow up.

OC submitted LAHOP # 54834 for IND dwelling in his van at Lewis Rd. This is the second submission.

OC submitted LAHOP # 54831 for A39. This is the second submission.

OC engaged A40 at Ladyface Laundry. IND stated that he may receive a train ticket from a friend. IND was visiting with a childhood friend who is a resident of Agoura Hills. IND received a list of resources.

OC checked the location at Las Virgenes Rd. and Agoura Rd. C33 was not at the location and the camp was clean. IND may have left the area. OC to follow up.

OC checked under the Agoura Rd. Bridge. No encampments were located, and the area was clean. OC updated Michael McConville.

OC canvassed The Commons several times this week. No new contacts.

OC canvassed The Courtyard several times this week. No contacts.

OC located C31's vehicle that was parked at The Commons. IND was not in his vehicle. OC updated Michael McConville, Management Analyst.

OC received a request from the city regarding Male, 20s. IND is living with his grandmother and has until Saturday to find a place to stay. IND stated that he is moving in with his father in Berkeley Ca. OC updated Peter K., Council Member.

OC received a notice that an individual experiencing homelessness has been seen walking Calabasas Rd. near the car dealerships early in the AM. OC walked the fence line of the old driving range and located a large hole cut in the fence. OC also spotted a shopping cart with some belongings on the far side of the vacant lot. OC notified Michael McConville, Management Analyst.
