

## Outreach Coordinator Weekly Update

### **Agoura Hills:**

OC canvassed Twin Oaks and Agoura Meadows several times this week.

Daily check-in with JT Manwell, Public Safety Liaison.

OC received a request from the city regarding an IND who is living in his vehicle. OC to meet with IND on Thursday morning. OC to follow up.

OC met with a new contact: A45 is a local resident who has been living in his vehicle after losing his job and housing. IND is willing to work and receives SS benefits. OC forwarded a list of resources and suggested he investigate a safe parking program. Louis has reached out to local faith organizations that may be able to assist in some way. OC submitted LAHOP #61264.

A45 stated that he contacted a Safe Parking program in North Hills and submitted all necessary paperwork. IND will possibly be accepted by Friday evening. OC to follow up next week.

OC canvassed T.O. Blvd., Kanan Rd., and Agoura Rd. several times this week.

### **Calabasas:**

OC canvassed The Commons and Civic Center several times this week.

OC contacted C38 by phone. IND to meet with LAHSA Outreach and OC tomorrow at 9:30 am. IND to transport to DMV to replace his ID if there is time. IND continues to refuse shelter at SFVCMHC.

OC met with Michael McConville for updates.

OC coordinated with LAHSA Outreach to transport Harrison to the DMV in T.O. IND was able to replace his ID which will arrive in the mail in approximately two weeks.

Daily check in with Sd De Mateo.

OC canvassed Calabasas Rd. and Parkway Calabasas several times this week.

OC was notified by SD De Mateo that several calls have been received by the city regarding INDs who may be experiencing homelessness that were seen walking around town. OC to follow up.

### **Hidden Hills:**

OC canvassed Mureau Rd. and checked the gazebo on Round Meadow. No contacts.

OC checked in with security at Long Valley Gate.

### **Malibu:**

OC received a request from the city regarding an encampment in Legacy Park. OC located the camp which was vacant at the time. OC to follow up.

OC canvassed Central Malibu and noticed several new INDs experiencing homelessness. OC to follow up.

OC checked in with Susan D. Public Safety Manager for updates.

OC checked in with Luis F. and verified that the encampment in Legacy Park had been removed. OC and Luis to canvass Zuma Beach and Trancas this week.

OC and Luis F., Public Safety Liaison canvassed Zuma Beach and engaged M26 near the restrooms. The area has been significantly cleaned up since last week. IND stated that he had taken over the encampment from the prior occupants and is not responsible for the mess. OC notified IND that Beaches and Harbors are planning a clean-up of the area but will post signage 72 hours prior to the effort to enable IND to remove any items of value. OC to follow up. IND continues to work with TPC for housing. Two other small encampments remain in the area which were vacant at the time.

OC and Luis also canvassed Trancas. No contacts.

OC and Luis to canvass Tuna Canyon early next week to ensure no encampments have been re-established after the recent clean-up effort.
