

## Outreach Coordinator Weekly Update

### **Agoura Hills:**

OC canvassed Twin Oaks and Agoura Meadows several times this week. No new contacts.

Daily check-in with JT Manwell, Public Safety Liaison.

OC met with Louis C., Deputy City Manager, for updates.

OC and JT Manwell responded to a request from the city regarding a new encampment that was set up on the vacant lot at Kanan and Agoura Rd. IND was informed that the property owner has a LOA on file with the LHSD and will have to remove his encampment. IND was agitated. OC to follow up.

OC updated Louis C. Deputy City Manager.

OC canvassed Morrison Park and 6:30am and again at 1:00pm. Several times this week. No contact was made with individuals experiencing homelessness.

OC informed JT Manwell that the IND at Kanan and Agoura Rd. has not removed his encampment as of 6:30am.

JT Manwell stated that LHSD responded to the vacant lot at Kanan and Agoura rd. and informed IND that he must remove his camp due to the LOA.

The encampment referenced above was vacant as of Friday morning. Some items/garbage remain.
