### **Agoura Hills:**

OC canvassed Twin Oaks and Agoura Meadows several times this week. No new contacts.

### **Calabasas:**

### **Malibu:**

OC engaged M77 at a bus stop on Westward Beach Rd. OC suggested he speak to TPC but has been service resistant. OC notified IND that complaints are being submitted to the city regarding his encampment. OC followed up later in the day and the encampment was removed.

OC engaged M78 who is dwelling in his vehicle on Westward Beach Rd. OC referred IND to Safe Park LA. IND attended lunch. IND has spoken to TPC Outreach. OC to follow up.

OC canvassed Trancas Market several times this week. No contacts.

OC attended lunch. Approximately 32 INDs participated on Tuesday.  
OC checked in with SD Espinoza.

OC engaged M56 at his camp near the Zuma Beach entrance. IND has not cleaned up his encampment as of today but stated that he will this morning.

OC engaged M26 at his camp near the Zuma Beach entrance. IND continues to work with TPC and stated that he is meeting with DMH this morning.

OC engaged M50 who has returned to the area recently. IND was not clear if he is working diligently with TPC. OC to follow up.

OC engaged M62 at lunch who is meeting with DMH and is interested in a shelter bed.

OC attended lunch. Approximately 30 INDs participated on Thursday.

#### **Westlake Village:**

New contact: Male, 30s. W05 has been loitering in front of Target for a couple of days. IND does not appear to be experiencing homelessness. IND has a hospital arm band and bandaged ankle/crutches. IND stated that he lives in Westlake but was speaking incoherently. OC asked if there was someone OC could contact, friend/relative. IND denied request. OC notified Daniel M., MET, however IND was not in crisis. OC forwarded IND a list of resources and updated SD Knott.

OC was notified by Daniel Moody, MET, that W05 was placed on a 51/50 hold. IND was loitering at Target and was generating calls to LHSD for behavior related issues.

#### **Other Activities:**

OC responded to a request from Supervisor Horvath's office regarding an IND who has been dwelling in her vehicle at Mulholland Hwy. The location is outside of incorporated cities. Female, 50s. C42 is parked in front of a private residence. IND has been at the location since she was trespassed by a neighboring residence. OC engaged IND who was displaying aggressive behavior at the beginning of the conversation but quickly calmed down. OC suggested a Safe Parking program to IND and discussed the benefits of such a program. IND denied any type of services. OC submitted LAHOP # 69189 and updated the requestee. OC updated Terry D., COG Executive Director.
