Agoura Hills:

OC located and engaged new contact: A60, female, 60s. IND has been seen at the library recently and appears to be in poor condition. OC located IND near Wendys on T.O. Blvd. IND stated that she is experiencing homelessness. IND rented a room in the past. IND appears to suffer from mental health issues. IND stated that she does not want to go to shelter. OC and JT Manwell to attempt to contact family and update.

OC canvassed Old Agoura and Chumash Parks. No contacts.

OC contacted Daniel M, MET regarding A60 and discussed concerns regarding INDs physical and mental health. MET will attempt to locate this Saturday and engage. OC to follow up.

OC was notified regarding an encampment at Islands Restaurant on Agoura Rd and Kanan. OC located IND who was sleeping. IND did engage and was given a list of resources. IND was not at the location when OC returned in the afternoon. Several belongings and garbage remain in the area. OC updated JT Manwell, Public Safety Liaison.

OC checked Islands on Friday. The IND camping at the location has moved on. The area is scheduled to be cleaned today.

Calabasas:

OC engaged C50 at Starbucks on Agoura Rd. OC informed IND that OC and LAFH Outreach attempted to locate him without success. IND stated that he is still trying to work something out with family and spoke to his mother this morning. IND is service resistant but may be open in the future.

OC was notified that the LAFH Outreach contacted C50 on Tuesday morning. IND remains service resistant. LAFH Outreach to continue coming out to build trust with IND. OC to follow up.

OC responded to a city request regarding an IND experiencing homelessness. OC left a VM and email and is waiting for a response. OC to follow up. No response as of Friday.
