Agoura Hills:

OC canvassed Twin Oaks and Agoura Meadows shopping centers several times this week.

OC canvassed Agoura Rd, T.O. Blvd and Kanan Rd. several times this week.

Daily check-in with JT Manwell, Public Safety Liaison.

OC canvassed I-Hop shopping center.

OC and JT Manwell verified that the small encampment at McDonalds belongs to A06 who is working with HOTM. IND has turned down two opportunities at interim housing.

OC and JT Manwell took photos from the parking lot of Mejico Grill that shows easy access to the establishment. INDs experiencing homeless may be going inside. Louis C, Deputy City Manager has been updated.

OC attempted to locate A60 without success on Friday. OC was notified that IND showed up at the library Thursday night and convinced staff to call emergency services. OC notified Daniel M, MET.

Calabasas:

OC canvassed the Community Center several times this week. No new contacts.

OC canvassed The Commons/Courtyard several times this week. No new contacts.

OC canvassed Shadow Hills/Malibu Hills Rds. No new contacts.

OC canvassed Creekside Village several times this week. No new contacts.

OC canvassed Gelson's Market. No contacts.

OC was notified that a tent was seen near Creekside Park on Old Topanga Cyn Rd. OC checked with staff who were unaware of any encampments nearby. OC was later updated that the camp was off Las Virgenes Rd near De Anza Park. OC and SD De Matteo located the tent but was vacant at the time. OC and SD to check earlier in the day on Wednesday. Michael M, Deputy City Manager has been updated.

OC engaged A60 at Albertsons and purchased IND coffee. OC contacted Daniel M, MET who has been attempting to locate IND. IND is not in crisis but is in poor physical condition. LAHOP #83539 was submitted last week. OC and MET to continue working toward a positive solution.

72-hour notice of encampment removal has been placed at the small encampment off Las Virgenes and Lost Hills Rd.

OC engaged C50 at De Anza Park. IND was loitering near the summer camp area. IND remains service resistant. OC updated park staff and Michael M, Deputy City Manager.

The encampment on Las Virgenes and Lost Hills Rd was removed, and the items will be held in storage for 30 days.

Hidden Hills:

OC checked in with security at Long Valley Gate. OC was informed that an IND caused a disturbance at Burbank Gate and was detained by law enforcement. It is unclear if IND is experiencing homelessness.

OC canvassed Mureau Rd and checked the gazebo on Round Meadow several times this week.

Malibu:

Mandatory shopping cart retrieval to take place on Tuesday, August 27th at 10:00 am. Some INDs have been notified that a large trash bin will also be available to dispose of unused items.

OC attended lunch. Approximately 40 INDs participated.

New contact: Female, 60s. IND stated she is waiting for remodel at friend's house for room. Service resistant at this time but may qualify for assistance. OC to follow up.

New Contact: Male, 60s. IND and OC engaged and spoke about signing up for services with TPC to start working on a housing plan. It appeared that IND was unaware of the outreach team. OC discovered that TPC Outreach has contacted IND in the past. OC to follow up.

OC attended lunch. Approximately 40 INDs participated.

OC canvassed Legacy Park. No new encampments were discovered. OC notified several INDs that there will be a cart retrieval on Tuesday the 27th.
