Agoura Hills:

OC and JT Manwell canvassed the vacant lot at Agoura Rd. and Kanan Blvd. A creek cleanup took place over the weekend and a small encampment was photographed and sent to the city. OC was unable to locate any sign of the camp. OC updated Louis C, Deputy City Manager. OC to follow up.

OC canvassed the vacant lot at Cornell and Kanan. The area remains clear of encampments.

OC canvassed Twin Oaks and Agoura Meadows shopping centers several times this week.

OC canvassed T.O. Blvd, Kanan Rd, and Agoura Rd several times this week.

OC attempted to locate A06 to discuss transitional housing at SFVCMHC. OC was unable to locate IND.

OC and JT Manwell engaged new contact: Female, 40s. IND stated that she stayed overnight in the area. IND accepted a list of services and is not planning on staying in town.

Calabasas:

OC engaged (C52) who was sleeping in front of a business on Park Sorrento. IND stated that he reached out to the service providers that OC forwarded last week. IND stated that they weren't providing services. IND is service resistant. OC to follow up. OC updated Michael M, Deputy City Manager.

OC canvassed The Commons/Courtyard several times this week.

New contact at The Commons. Male, 30s was playing his guitar. IND stated that he is not camping in the area and accepted a list of resources.

OC canvassed Creekside Village several times this week.

OC was notified of an IND who was sleeping in front of the library. OC was in the area at 7:30 am and did not see anyone sleeping at the time. An IND was sitting at the table but did not appear to be experiencing homelessness. OC to follow up on Monday.

OC engaged C50 at Jack N The Box who stated that he was in Thousand Oaks and has returned to the area. OC asked IND if he was interested in transitional housing at SFVCMHC. IND stated that maybe in a couple of weeks and that he would get back to OC.

Hidden Hills:

OC canvassed Mureau Rd. several times this week and checked the gazebo on Round Meadow. No contacts.

OC checked in with security at Long Valley Gate. Nothing new to report.

Malibu:

OC canvassed Central Malibu and engaged M102 who has been in the area for some time. IND stated that he is working with TPC and is thinking of heading to Hollywood for a break. OC and IND spoke about the process and the importance of remaining in contact with his CM if he travels out of the area.

New contact: Female, 70s. IND just arrived in the area in the last several days. (M103) has met with TPC. OC to follow up.

OC attended lunch on Thursday. Approximately 30 INDs participated.

OC was notified of an IND experiencing homelessness that was contacted near Lakeview Canyon Rd and Agoura Rd. OC verified that A47 has been in the area for several weeks and remains service resistant.
