OC contacted Daniel M, MET who contacted C54. IND generated several calls to SD on Thursday. IND has had contact with Urban Alchemy in Santa Monica. OC contacted the organization to update. OC continues to wait for a response from LAHOP #87282. IND as an extensive history in HMIS and Mental Health. OC to follow up.

OC and Allied Security located many personal items that belong to C34 which are located near a retaining wall on the hillside behind the Civic Center. Michael M, Deputy City Manager has been updated.
