Agoura Hills:

OC was notified by SDs regarding an IND at Agoura Deli that may be interested in services. OC to attempt to locate IND on Wednesday.

OC attempted to locate IND experiencing homelessness near Agoura Deli without success. IND spoke to SDs and stated that he may be interested in services. OC to follow up.

OC canvassed Twin Oaks and Agoura Meadows several times this week.

OC canvassed Agoura Rd, T.O. Blvd and Kanan Rd several times this week.

OC canvassed Canwood St. several times this week.

Two vehicles that were parked long term in the Canwood Park and Ride have moved. OC updated Louis C, Deputy City Manager. IND was not interested in receiving services.

Calabasas:

New contact: Male, 40s on Calabasas Rd. IND was walking toward Old Town early. IND accepted a list of resources and was seen leaving the area.

OC attended the quarterly Safety Coordination Meeting.

OC canvassed The Commons/Courtyard several times this week.

OC canvassed Creekside Village several times this week.

OC was notified that an IND experiencing homelessness was sighted at the vacant lot next to the BMW Dealership. OC canvassed the area but did not locate anyone or any signs of an encampment. OC updated Michael M, Deputy City Manager.



OC responded to a request from the city regarding an IND camping near the corner of Calabasas Rd and Mureau Rd. IND stated that he was passing through the area headed north. OC declined a list of resources. OC updated Michael M.

OC engaged new contact at Las Virgnes/101 Fwy. Male, 30s. IND stated that he is working with Hope of the Mission and waiting to be matched to housing. IND is not camping in the area. IND was with his girlfriend panhandling. OC updated Michael M.

Hidden Hills:

OC checked in with security at Long Valley Gate. Nothing to report.

OC canvassed Mureau Rd and checked the gazebo on Round Meadow several times this week. No contacts.

Malibu:

OC canvassed Central Malibu and Legacy Park INDs experiencing homelessness are accumulating shopping carts near the entrance to the park. A cart retrieval is planned for December. OC to follow up.

OC engaged M93 near Legacy Park. IND does not have any plans to move forward with housing at this time. OC to follow up.

OC canvassed Trancas shopping center. No new contacts.

OC canvassed the Zuma Beach entrance. No encampments were in the area.

OC canvassed Westward Beach. 1 Rv and two vans were located.

OC engaged M10 at lunch. IND remains on the fence regarding housing. IND is concerned that he would not do well in a congregant shelter. OC assured IND that it is not a requirement for housing but that it can speed up the process. OC to follow up.

OC engaged M98 at the corner of Heathercliff and PCH. IND remains service resistant.

Westlake Village:

OC was notified by the city regarding an IND experiencing homelessness at the corner of Agoura Rd and Lindero Canyon Rd. OC engaged IND who stated that he was waiting for someone to pick him up. IND was not interested in services.

OC was notified of an IND panhandling at the entrance of Shoppes at Westlake Village. OC arrived and located INDs belongings that were left at the corner. IND eventually arrived in a van to collect his belongings. IND stated that he and his family are dwelling in their vehicle. OC forwarded a list of resources and discussed Safe Park LA and suggested IND reach out to LA Family Housing.

OC was notified that several INDs experiencing homelessness were sleeping on the island on Watergate St, OC canvassed the area and did not see any signs of encampments. OC to follow up in the early morning hours.

OC responded to a request from SDs regarding an IND who has been loitering for long periods of time in The Landing bathrooms. IND has been trespassed from the facility. IND was not at the location when OC arrived. It is not clear if the IND is experiencing homelessness. OC to follow up.
