

Outreach Coordinator Weekly Update

February 10-14

Agoura Hills:

OC canvassed Twin Oaks and Agoura Meadows shopping centers several times this week.

OC and JT Manwell, Public Safety Liaison attempted to locate PEH who has been sleeping in the bathroom at Old Agoura Park. Personal belongings were in the restroom, but PEH was not at the location on Monday or Tuesday. OC to follow up.

New contact: Male, 40s. A64 is dwelling in his vehicle and moves around the area. PEH is waiting for his registration and needs to renew his DL. OC suggested Safe Park LA and HOTM for services. IND stated that he would visit the service provider today. OC to follow up.

OC and JT Manwell transported A65 to SFVCMHC to complete her intake. IND gave positive feedback regarding her experience at the facility. PEH needs to make an appointment with her CM and return to pick up an ID Voucher for ID replacement.

OC attempted to locate A65 on Friday. PEH stated that she would likely be found at the library or the Community Center. PEH was not located at either location after several attempts during the day. OC to follow up next week.

Calabasas:

New contact: Female. PEH was sleeping at the bus stop on Calabasas Rd and Parkway Calabasas. PEH did not engage with OC but accepted a list of resources. OC to follow up. OC updated Michael M, Deputy City Manager.

OC canvassed Calabasas Rd and Old Town several times this week.

OC canvassed The Commons/Courtyard several times this week.

OC canvassed Creekside Village several times this week.

OC checked under the Agoura St. Bridge. No new contacts.

OC submitted LAHOP #92454 for PEH that has been seen early in the mornings at Coffee Bean. IND did not engage with OC at last attempt. OC to follow up.

The PEH who was engaged on Monday and seen again Wednesday at the bus stop near Calabasas Rd. and Parkway Calabasas was not at the location as of Friday. PEH accepted a list of resources.

OC engaged A64 at Mc Donalds. PEH is dwelling in his vehicle and has been engaged in Agoura Hills and Calabasas. PEH stated that he went to the HOTM Navigation Center and was denied services because he is not living in the area around the facility. PEH can utilize the access center in Van Nuys. PEH needs to renew his DL and is waiting for his registration to arrive in the mail. PEH is aware of Safe Park LA. OC to follow up.

Hidden Hills:

OC checked in with security at Long Valley Gate. Nothing to report.

OC canvassed Mureau Rd several times this week. No contacts.

Malibu:

OC was notified that another tent has been set up in Legacy Park. M56 was contacted by SD. IND continues to work with TPC.

OC attended lunch on Tuesday. Approximately 10 PEH participated.

OC engaged M91 at Legacy Park. PEH stated that he continues to work with TPC, and the housing process is moving slowly. OC reminded PEH that it takes time. IND is not sure that he will stay in the area. OC to follow up.

M99 has self-exited from Turning Point and returned to Malibu. TPC Outreach is aware of the situation.

OC engaged M111 at the Library. Due to the heavy rains, several PEH were in the area and the library was closed for the day. Lunch was served at the location and approximately 10 INDs participated on Thursday.

Westlake Village:

OC canvassed Civic Center at 6:00 am to locate PEH dwelling in her vehicle. IND has been seen at the location several times. OC did not locate PEH and will make another attempt on Wednesday.

OC canvassed Smart and Final shopping center several times this week.

OC was informed by LHSD that a PEH was found sleeping in front of the liquor store on Agoura Rd. and Lakeview Cyn Rd. OC located PEH at the bus stop. OC attempted to engage, however PEH was speaking incoherently and appeared intoxicated. OC to follow up.

OC canvassed Westlake Village Community Park/YMCA. No contacts.
