One is working with a service provider in Ventura County and has been waiting to be matched to housing for some time. The other has a full-time job is working towards self-resolving. OC suggested that PEH sign up with a Safe Parking resource provider. OC to follow up. OC updated Jonah Glickman at Supervisor Horvath's office.
