### **Agoura Hills:**

OC responded to a request that was submitted on the city website outreach portal. OC informed IND by phone that there are no shelters in the Calabasas area. IND is from Georgia and was planning on relocating but stated on the phone that she has changed her mind.

OC canvassed the Community Center and checked in with staff. Nothing new to report.

OC canvassed Grape Arbor Park. No contacts.

OC canvassed Shadow Hills and Malibu Hills Rd. No contacts.

OC responded to a request that was submitted on the Outreach Portal. OC connected by phone and emailed a list of resources.

OC was notified of a tent located at Wild Walnut Park. The location appears to be abandoned, and public works is to place notice of removal signs. OC to follow up.

OC checked in with security at Long Valley Gate. Nothing new to report.
