### **Agoura Hills:**

OC submitted LAHOP # 94570 for C61 who was seen walking through The Commons on Wednesday morning.

OC woke up C59 who was sleeping in the doorway of Chase Bank on Wednesday. PEH did not engage.

The move in date for C60 has been postponed for 10 days due to a paperwork error at LA Family Housing. Additional funding has been secured for her continued hotel stay.

OC contacted LAFH Outreach who visited the COG area of Thursday. The team was unable to locate PEH but did meet with C60 for follow up on housing.

OC attempted to engage C61 at The Commons on Friday. PEH did not engage.

OC checked under the Agoura St. Bridge several times this week. No contacts.

OC canvassed Malibu Hills Rd. where C07 continues to park both of his vehicles.
