Agoura Hills:

OC canvassed Civic Center early in the morning several times this week. No contacts.

OC canvassed Twin Oaks and Agoura Meadows several times this week. No contacts.

OC canvassed Agoura Rd, T.O. Blvd and Kanan Rd. several times this week.

W01 continues to camp on the hillside off Agoura Rd. The No Trespassing signs that were placed last week were not at the location as of Monday.
