

## Outreach Coordinator Weekly Update

### **May 19-23**

#### **Agoura Hills:**

OC canvassed Civic Center parking lot at 6:05 Am. No new contacts.

OC canvassed Twin Oaks and Agoura Meadows several times this week.

OC attended lunch. New contact. Male, 40s. PEH has been in the area for about a week and is interested in inpatient treatment and needs to replace his ID. OC connected him to TPC Outreach. OC to follow up.

OC engaged M10 at lunch. PEH stated that he is having difficulties following the rules at Turning Point. PEH may have lost his bed. PEH also spoke to Jimmy, Outreach Case Manager. OC to follow up.

OC canvassed Trancas and verified that the encampment on PCH and Broad Beach has not been removed as of Thursday. OC updated Luis F, Public Safety Liaison. A 72 hr notice of removal will be placed at the location on Tuesday, May 27<sup>th</sup> dated Thursday May 29<sup>th</sup>.

OC canvassed Zuma Beach. An encampment was located near Tower 4. OC update SD Espinoza and Luis F.

OC attended lunch on Thursday. Approximately 25 PEH participated.
