Agoura Hills:

OC contacted LHSD HOST Team regarding the encampment located near the creek at Kanan and Agoura Rd. SD Sheklo stated that he may be able to come out this Friday. OC to follow up. OC updated JT Manwell, Public Safety Liaison.

OC canvassed Twin Oaks and Agoura Meadows several times this week

OC canvassed Agoura Rd, T.O. Blvd and Kanan Rd. several times this week.

OC followed up with SD Sheklo, HOST on Wednesday. The team will visit the area on Thursday and attempt to contact PEH at the encampment near the creek. OC updated Louis C, Deputy City Manager.

OC engaged new contact. Female, 20s at Jack in the Box. PEH accepted a list of resources but did not engage further with OC.

OC and JT Manwell met with the HOST Team at the encampment near the creek. The city is in coordination with the property owner who will place permanent No Trespassing signs and schedule a cleanup. HOST to return next week to place removal signs. OC to follow up.

Calabasas:

OC was notified of a PEH who is dwelling in their vehicle at Park Granada that was contacted by Allied Security on Saturday. OC canvassed the area on Monday but was unable to locate PEH. OC updated Michael M, Deputy City Manager.

OC canvassed Calabasas Rd, Parkway Calabasas, Park Granada and Park Sorento several times this week.

OC canvassed Creekside Village several times this week. New contact: Male, 30s. PEH stated that he is not interested in services.

OC engaged new contact, Male, 30s who was sleeping at the bus stop on Park Granada and Calabasas Rd. IND stated that is not experiencing homelessness but was unable to check in at The Anza in time the previous evening.

OC engaged new contact: Male, 30s who is dwelling in his vehicle in the Mc Donalds parking lot. PEH stated that he is currently working and saving for an apartment. OC forwarded a list of resources.

OC engaged C38 who continues to stay in a hotel and working on putting together his brand. IND is receiving assistance and is no longer experiencing street homelessness.

Hidden Hills:

OC checked in with security at Long Valley Gate. Nothing new to report.

OC canvassed Mureau Rd several times this week.

Malibu:

OC verified that the area at Broad Beach Rd. and PCH remains clear of encampments.

OC attended lunch on Tuesday and Friday. Approximately 15 PEH participated.

OC canvassed Zuma Beach boardwalk and engaged new contact. Female, 50s. PEH stated that she has been in the area for about a week. PEH was in Santa Monica and Venice Beach. OC informed PEH about TPC Outreach and the lunches. PEH appears interested in services. OC to follow up. OC notified TPC Outreach.

OC engaged M16 at Zuma Beach. PEH stated that he was staying with a friend in Santa Monica. PEH is reconnected with TPC Outreach. PEH stated frustration that all his friends have been housed. PEH understands that because he leaves the area frequently, the housing process will continue to be a challenge. OC to follow up.

OC canvassed Central Malibu. No new contacts.

Westlake Village:

OC was informed that W10 was detained and placed on a 51/50 mental health hold over the weekend.

OC canvassed Agoura Rd, Lindero Cyn Rd, Russell Ranch Rd and T.O. Blvd several times this week. No new contacts.
