#### **Agoura Hills:**

OC engaged M85 at Zuma Beach. PEH stated that she lost her bed at Turning Point because she did not occupy the first night. OC and TPC Outreach to continue working with PEH.

OC attended lunch on Tuesday and Thursday. Approximately 15 PEH attended on both days.

### **Westlake Village:**
