### **Agoura Hills:**

OC canvassed Twin Oaks and Agoura Meadows shopping centers. No new contacts.

OC canvassed Agoura Rd, T.O. Blvd, Kanan Rd. Reyes Adobe Rd and Canwood St. several times this week.

OC canvassed I-Hop shopping center several times this week.

The area under the 101 Fwy between Roadside and Canwood St. has been cleaned. It does not appear that PEH have returned to the area.



### **Calabasas:**

OC canvassed the Civic Center and checked in with city staff.

OC canvassed The Commons and engaged C65. PEH stated that he is meeting his father who is bringing him fresh clothes. PEH stated that he lives in the area. OC informed PEH that an outreach team will attempt to make contact. PEH is service resistant currently. OC to follow up.

OC canvassed Calabasas Rd, Parkway Calabasas, Park Granada and Park Sorrento. No new contacts.

OC canvassed Creekside Village and checked under the Agoura St. Bridge several times this week.

OC engaged PEH behind the Civic Center. Male, 50s. PEH stated that he is trying to leave the country and is not interested in services. PEH was engaged several months ago and has not been seen in the area since that time.

OC engaged new contact at The Commons. PEH was sleeping in front of the bank. PEH was irritated and did not want to be bothered. PEH walked up Calabasas Rd. toward Lovi's Restaurant.

OC engaged new contact at Creekside Village. Female, 40s. IND stated that she is not homeless but was seen sleeping in the elevator by maintenance. IND is service resistant currently. OC to follow up on Friday if IND remains in the area.

OC made a second attempt to engage female at Creekside Village on Friday. PEH stated that she has a house and is trying to return to Agoura Hills. OC stated that the bus runs directly across the street. PEH stated that she is okay.

OC engaged new contact at McDonalds: Male, 20s. PEH stated that he and his partner are staying at the Good Night Inn and are currently working with LA Family Housing. PEH are on the housing wait list and maintain frequent contact with their Case Manager. OC to follow up.

OC attempted to engage C65 at The Commons. PEH stated that he did not have time to talk.

OC contacted LAFH Outreach who scheduled a time to visit the area on Monday, August 4<sup>th</sup>. 9:00 am. OC and LAFH to outreach SPA 2 cities.

OC attempted to engage C28 in unincorporated Calabasas. PEH remains service resistant.

### **Hidden Hills:**

OC checked in with security at Long Valley Gate. No new contacts.

OC canvassed Mureau Rd. several times this week. No new contacts.

### **Malibu:**
