Agoura Hills:

OC engaged M13 on Cross Creek. PEH was released from jail and is required to complete a 90-day residential treatment program. OC suggested PEH work with TPC Outreach who can assist in locating a bed. PEH was connected to TPC. OC to follow up.

OC engaged a new contact at the library. Male, 20s. PEH is familiar with TPC Outreach. OC suggested PEH work with the team toward transitional housing. OC to follow up on Wednesday.

OC attended lunch on Tuesday and Thursday. Approximately 25 PEH participated.
