HOW TO RESEARCH OR REQUEST PUBLIC RECORDS

STEP 1

REQUEST YOUR TAX ASSESSOR RECORDS

The LA County Tax Assessor's office has given the city copies of tax assessor records for all properties affected by the Woolsey Fire. To access those records please:

1. If you're a Property Owner: Come to City Hall with proof of ownership and a matching ID.
2. If you are representing a property owner: Have this form completed and notarized before coming to City Hall.

STEP 2

RESEARCH EXISTING digitized public records using the City's electronic files system- ONBASE

1. Go to  [MalibuCity.org/Records](https://www.MalibuCity.org/Records)
2. Click on OnBase
3. To search for property records, use the drop down and select "ESD – Geology Files"
4. Enter in your street number and select street name

STEP 3

SUBMIT A REQUEST for hard copy public records online or in person

1. Go to www.MalibuCity.org/Records
2. Click on "Submit a request for public records here."
3. Create a new user account or sign in using existing credentials as needed
4. Fill out the request form, listing addresses in which you are interested and specifying that the request is fire related.
5. Staff will respond with a status update within 10 days. If there are files available for review, staff will arrange an appointment in which to do so.

* If you prefer to submit your request in person, please fill out the form attached to this document and return to City Hall during normal business hours.

STEP 4

REQUEST ADDITIONAL RECORDS for your property from the California Coastal Commission

Email Barbara Rodriguez at BRodriguez@coastal.ca.gov to request records from the South Central Coastal Commission office in Ventura with the assessor's parcel number (APN) and owner's name, or previous owner's name, in addition to your street number and name. Records available for properties in Malibu from this agency date as far back as 1977, when the Commission was created. The office can also be reached at (805) 585-1800, and is located at 89 South California Street in Ventura.
