City of Malibu to Host COVID-19 Vaccination Site at City Hall April 13 for Malibu Residents

(Malibu CA) – The City of Malibu is partnering with the Los Angeles County Department of Public Health (LADPH) and Curative to host a mobile vaccination site for people who live or work in Malibu on Tuesday, April 13 from 8:00 AM to 5:00 PM at Malibu City Hall.

“I understand the anxiety, frustration and confusion that community members are struggling with about when, where and for whom the COVID-19 vaccines are available,” said Mayor Mikke Pierson. “I am proud that the City can offer vaccines here for our residents so that they can keep themselves and their loved ones healthy and safe and we can beat the pandemic.”

There is no cost to receive the vaccine. Appointments are limited and are available to people who work or live in Malibu and who are currently eligible for vaccination in Los Angeles County. Those arriving to receive a vaccine must wear a face covering, and bring valid identification and insurance information. City Hall is located at 23825 Stuart Ranch Road, Malibu, CA 90265.

Appointment times will be emailed to residents by Monday, April 12, 2021, and cannot be pre-scheduled or re-scheduled. Residents should sign up only if they can confirm they are available on Tuesday, April 13 between 8:00 AM and 5:00 PM and are available to receive the second vaccine dose on Friday, May 7 at City Hall.

Those eligible to receive a vaccination as of April 1 in Los Angeles County include:

- People employed in industry sectors covered under Phase 1A and Phase 1B of the Los Angeles County vaccination program. See Phase details: <http://publichealth.lacounty.gov/acd/ncorona2019/covidvaccinedistribution>
- People with serious health conditions or disabilities
- People aged 50 and over
